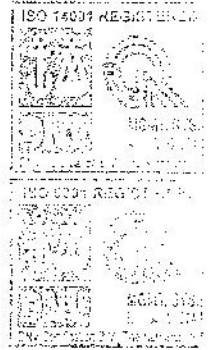

- Taxes: - GST as applicable will be paid extra.
- Income tax: - income tax if applicable will be deducted at source.
- Completion time: Within 20 days from the date of site clearance.
- Penalty: - In case work is not completed within 20 days, penalty @ 1% per week subject to max of 10% will be levied. In case of in-ordinate delay PACL also reserves the right to get the work done from other sources at your risk and cost.
- Quantities mentioned above may vary+-10%. Payment will be made for actual work done as verified by our site in charge.
- Contractor will have to ensure that their workmen are covered under Insurance.
- Contractor to provide all safety personal protective equipments to their workers where ever required. Scaffolding to be used if any should be of STEEL (Bamboo not allowed)
- We reserve the right to accept /reject in part or full, any or all offers without assigning any reason thereof. Offers received late are likely to be rejected.
- Contractor will have to abide by the various labour laws as applicable from time to time including deposit of PF, ESI and other payments etc.



- k) Contractor will ensure that all safety measures are taken by them for their workmen working at our site to avoid any injury to the manpower.
- l) Contractor will also ensure that work is completed with utmost care and without any subsequent damage to our plant and machinery. In case of any loss is incurred by PACL due to negligence of your manpower, the same will be recovered from the contractor.

5. **ARBITRATION CLAUSE:**

In all cases of dispute of disagreement between the purchaser and the supplier as to any matter arising out of or relating to this purchase order/work order whether such dispute or disagreement shall arise during the continuance of the work order/purchase order regarding interpretation of this Work Order of any Clause or Clauses thereof or upon or after the termination hereof and provided no understanding between the parties can be reached for the settlement of the difference, shall be referred to the sole arbitrator of the Managing Director of Punjab Alkalies & Chemicals Ltd or any officer appointed by him on his behalf in accordance with Arbitration and Conciliation Act, 1996. or any Statutory modifications or substitute thereof and all the provisions of that Act, so far as are applicable or of any of them for the time being in force shall apply to every reference hereunder.

The award given by such Arbitrator shall be final conclusive and binding upon the parties to this work order. The arbitrator may from time to time, with consent of parties, enlarge the time for making or publishing the award. The arbitration proceedings shall be held at Chandigarh.

Notwithstanding any pending reference to arbitration both parties shall precede with the execution of their commitments under the purchase order/work order until the arbitration award is known, unless the question of such continuance is a subject matter of such proceedings.

6. **LAW AND ITS JURISIDICION**

The wrk order shall be governed by the laws of Govt. of India in force from time to time and shall be deemed to have been concluded in the Union Territory of Chandigarh. All suits and proceedings shall be subject to jurisdiction of the courts at Chandigarh only.

Scope of work for Fabrication & Erection of CS/MS Pipes & Fittings.

1. CS/MS Pipes & Fittings Size 150MM Dia to be Fabricated & Erected about 1500 Meters apprx. (10% Variation)
2. Pre fabrication of CS/MS Pipes of various lengths.
3. All fabricated Pipes to be installed on already fabricated Racks , Pillars at different locations.
4. Fabrication / Erection of MS Structure supports for CS/MS Pipes at different floor elevation as per requirement.
5. All pipes to be joined with Flanges Joints where ever required.
6. Alignment of all CS/MS Pipes & Fittings on Pipe Racks.
7. All Tools & Tackles , Scaffolding Material, Chain Pulley Blocks , Ropes , Grinders etc. in the scope of party.
8. Hydra Crane for Shifting & Erection jobs in the scope of party. However PACL can arrange Hydra Crane but payment to be given by the party.
9. Gas Cutting Sets including DA & Oxygen Gases , Heavy duty Welding Machines and Good Quality Welding Electrodes are in the scope of party.
10. All CS/MS Pipes & Fittings , Nuts & Bolts and Rubber / Asbestos Gaskets shall be given by PACL free of cost to the party.
11. Party to take care while using material so that there is no wastage of material issued by PACL.
12. Scope of work may be varied from +/- 10% allowed.
